#### OJR to Implement Later School Start Times; Full-Day Kindergarten

Over the past few years, the Owen J. Roberts School District has pursued the opportunity to re-evaluate the needs of students, explore best practices that support classroom-learning environments, and develop strategies that foster greater academic achievement from students. We are excited to share with you two game-changing administrative recommendations recently approved by the Board of School Directors this past January,

After careful consideration, the School Board has approved beginning the transition to push back school start times and dismissals in Owen J. Roberts, beginning with the 2024-2025 school year (next year).

In addition, the School Board approved that the administration proceed with the implementation of Full-Day Kindergarten beginning with the 2025-2026 school year (two school years from now).

As part of the proposal to change school start times, instruction at the high school and middle school will be pushed back 30 minutes, beginning at 8 a.m. and ending at 2:45 p.m. In addition, we will push back instruction at our elementary schools by 20 minutes, with classes beginning at 8:50 a.m. and dismissing at 3:30 p.m.

The schedule change also means that elementary schools will hold their morning half-day kindergarten programs from 8:50 a.m. until 11:35 a.m.., while afternoon kindergarten programs will run from 12:35 p.m. until 3:30 p.m.

The decision to move forward with changes to OJR's school start times is based, in-part, on the district's ability to hire school bus drivers to serve the transportation needs of our community.

Previously, OJR faced a severe shortage of bus drivers and shared that any proposed school start time change would require additional drivers. However, the district's administration previously shared with the community their intention to continue pursuing a path toward later school start times for students while prioritizing efforts to address OJR's bus driver shortages.

In November 2023, the Transportation Department provided an update on school bus driver staffing during the Working Session of the Board of School Directors. During the meeting, it was announced that as a result of recruitment efforts, OJR is now fully-staffed with 90 buses with full-time drivers, 3 full-time office staff, and 1 full-time lot mechanic. In addition, the budget allowed for 4 additional buses, which were added this past January. The addition of 4 buses to OJR's service fleet will help to reduce ride times for students, help to reduce load counts on our buses, and enable buses to arrive earlier to the Elementary School Line-Up making for a smoother, quicker dismissal.

Regarding the implementation of Full-Day Kindergarten in our schools, the community has been clear in its desire to see Owen J. Roberts pursue this course of action and to have schools provide educational opportunities that align with those already being offered in neighboring school districts in Chester County and the surrounding region.

After assessing the classroom capacities and facility capabilities throughout the school district, the administration is confident it can effectively implement Full-Day Kindergarten in a timely and efficient manner, and with minor disruptions to students' learning environments.

In the coming months, OJR will share additional information about these changes, particularly regarding school start times, and provide plenty of time for families to make adjustments to their schedule ahead of the start of the school year in late-August. In the meantime, please visit our School Start Time portal, available on the OJR website, and consider reading the Question & Answer document that was compiled based on the feedback received from parents, teachers, students and the community.




I'm excited about what's coming next. High school is turning out to be a pretty cool experience, and I'm eager to see how the rest of my freshman year unfolds!

#### **OJR STEELS Update-Winter Edition**

The new Pennsylvania Science Standards were developed jointly to ensure consistency, coherence, and a cohesive K-12 integrated approach to science education in the Commonwealth.

Now, OJR teachers are in the process of restructuring instructional strategies to model a three-dimensional approach for learning science. This approach maximizes the connections between how students think, what students know, and ultimately what students do (products they will construct). The new standards label these components: Cross-Cutting Concepts (CCC), Disciplinary-Core-Ideas (DCl), and Science-and Engineering Practices (SEP).

OJR's science instruction will involve fewer expectations for memorization based on facts, whole class lectures, posing questions with only one correct response, the use of worksheets, or pre-planned "cookbook" labs, and activities that result in a single outcome. Moving forward, students will experience more opportunities to engage in discussion, work collaboratively, conduct investigations, create solutions for problems/challenges, analyze data, as well as write and maintain a journal of observations as they learn about the world around them.

Our STEAM program is in its second year. As a component of STEELS, it fully complements the state's integrated approach to collaboration, creativity, and problem-solving. The program's premise is to deliver instruction based on engineering concepts, coding, and robotics.

We would like to thank the Chester County Economic Development Council for loaning the district 14 Quest Headsets to research the possibility of Virtual Reality opportunities. There is no cost to the district for these devices and our students will have an opportunity to create an experience unique environments and activities such as launching Rube Goldberg machines.

The next K-12 STEELS Task Force will meet on February 21, 2024. This group includes not only teachers from every grade level and school- it has members from the community, administration, technology education, learning support, and our nurses are also represented. It will be the focus of the next session to align topics of study for every grade level and subject area. ### Superintendent's Notebook

As I write this, there's little doubt that we're right in the middle of the winter season! Not only are we coming back from our fourth weather-related Flexible Instructional Day (FID) of the school year, there's also an abundance of snow on the ground and plenty of chilly temperatures. However, while most people associate snow with a number of fun, seasonal activities (or chores), for superintendents snow typically means an early start to the work day and a great deal of planning.

Recognizing that not everyone is familiar with how we determine when to implement FIDs, I recently took a few minutes to walk our community through the process during my most recent <u>Superintendent Update</u> video. In addition to the overview of our procedures designed to address inclement weather, I hope you take a few minutes to watch the second half of the video in which Dr. Jeff Detweiler at West Vincent Elementary School shares the latest happenings at his school. Be sure to hit the subscribe button to stay up to date on the <u>latest happenings</u> in our school district!

Although we're only a few weeks into the start of 2024, it's been quite an eventful time for the Owen J. Roberts School District. The Board of School Directors recently approved two significant administrative recommendations we brought before them, and I'm incredibly excited about the future of our school district.

Starting in August, we will push back our school start times by 30 minutes in our secondary schools and 20 minutes in our elementary schools – with instruction at the high school and middle school taking place from 8 a.m. to 2:45 p.m. and elementary school instruction taking place from 8:50 a.m. to 3:30 p.m.

Like OJR, many school districts across the nation have begun adjusting their school start times to align with scientific research suggesting that teenage students, especially those in high school, require more sleep than existing school bell times have previously afforded them. As a result, these school districts have seen significant increases to subject matter retention and student academic performance, experienced improvements to student mental and physical health, and seen the positive benefits to student behavior and safety.

Based on numerous studies, extensive research, and my own personal experience as a parent and an administrator, I firmly believe that our students will experience the same benefits already enjoyed by their fellow students across the nation.

Prior to the School Board's decision, Owen J. Roberts conducted extensive research focused on school start times and student sleep health, as well as solicited multiple rounds of feedback on the subject from students, families, staff and the community. Beginning September 2022, the OJR School Start Time Planning Committee reviewed research and survey findings, discussed benefits and challenges, as well as looked at costs and other factors with the goal of developing a formal recommendation on school start times to present to the greater community.

OJR's research on the subject of school start times includes a wealth of sources from subject matter experts, sleep scientists, consortiums, public education entities and more. We've collected this information for families to review by visiting our School Start Time Web Portal at <a href="https://www.ojrsd.com/Page/10477">https://www.ojrsd.com/Page/10477</a>.

In addition to later school start times in August 2024, we're excited to announce the implementation of Full-Day Kindergarten (FDK), starting the following year, in August 2025. We know this is something the community has requested in the past, and we want everyone to know that we hear you and understand that this is a priority for families.

Implementing FDK provides a number of benefits to our students, including the creation of a solid basis for future academic success (learning how to be a learner), a deeper dive into content, a slower pace, the ability for reteaching and enrichment, and exposure to a wider range of subjects. In addition, a Full-day program provides more opportunities for academic content and a structured environment, while enabling staff to support emotional learning and focus on social development to build peer connections.

After assessing the classroom capacities and facility capabilities throughout our school district, I am confident that we can effectively implement Full-Day Kindergarten in a timely and efficient manner for the start of the 2025-2026 school year (the school year after next).

I appreciate that these changes represent a departure from our established operations and want to acknowledge that our community has a variety of opinions and preferences about the preferred path forward for our students. I also recognize that arriving at a consensus opinion is not always possible for every initiative and important decision we make as an administration. However, my priority is, and remains, charting a path forward that keeps with the best interest of students – even if that path forward brings unique challenges we must work to overcome together.

I believe the implementation of the operational changes we've recently announced will create a better, long-term learning environment for students. There will likely be some hiccups along the way, and there's no doubt that these changes will require time to fully adjust. But for all of our time and effort, I have no doubt that we will be better able to educate our students.

In closing, I want to thank everyone once again for your patience, feedback and participation in this important process. I want to especially thank the students, parents, staff and community members who served on the school start time committee and assisted us in this valuable work. I also want to thank every member of our community who has taken the time to attend our listening sessions and town hall meetings, and everyone who has emailed me their thoughts and ideas on these crucial topics.

I look forward to your ongoing partnership and support of our students as we continue to enjoy an amazing school year.
